#### **AWSC News**

The AWSC workshop was October 26-28 at Chula Vista in the Dells. Pat, Tami and Evan attended the workshop. They spoke about some of the things that they did while they were there. Tami learned about some membership issues and changes. Pat attended a groomer training. It sounds like there are also a lot of trails that won't be open up north due to the fact that there was a lot of storm damage and things are too wet to get to. We may have some of the same issues around here. Also, there was talk that the AWSC may raise the membership price and that will be voted on in March.

KAOS Update-Even gave an update from some of the things he learned at the workshop and said that their club ride will be February 8, 9, and 10<sup>th</sup>. The groups next camping weekend will be July 26-28, 2019 in Oakdale at Grangers Campground. All are welcome to come if anyone would like to go. The KAOS program is still looking for any donations for the spring convention.....we did approve up to \$100 for a basket for that event.

Sno-Odders gear link – the link is being worked on so that we can order Sno-odders gear ourselves whenever we want. Once the link is available, Pat will email the information out to the club.

# **Trail Report**

Trail Section leaders for the 2018-2019 season are still needed. We are still looking for a couple more volunteers to mark trails. We need someone to mark from Hwy E West to PP (this is a new trail so Pat will work to help anyone who wants to mark. We also need someone to mark the spur trail to borders. Please let Pat know if you are interested in volunteering.

Bridge on Northwestern Trail at FF – we will be crossing the bridge this year. We have to pull signs down and make sure that the bridge is safe for snowmobiles to cross.

Brushing and mowing – we have some spots that will need to be checked over.

\*\*Remember to document everything related to trails so it can get entered into SNARS. That includes calling landowners and checking trails. Everything is reimbursable, please write it all down and record it!

Groomer maintenance – Groomer still needs some maintenance done to it. Pat and Kyle will pick a date and will let everyone know if anyone wants to volunteer to help.

### **New Business**

Vote on Tuesday, November 6<sup>th</sup>. Be sure to research your candidate to be sure that they support snowmobiling. There are some candidates that are running that do not support snowmobiling at all.

Club W9, 990 and tax-exempt forms need to be filled out by the club Treasurer.

Storm damage on the Northwester trail – trees were down on the trail from the City of Ripon to PP. The city went and cleaned it all up. Pat will go and talk to them to see what they all did to see if we can submit the hours on SNARS.

Safety Class – The next Snowmobile and ATV safety class is TENTATIVELY scheduled for January 7, 8, 10 and 12, 2019 at the Town Hall.

Integrity Lawn – they sent us a letter that they have equipment available for us to hire them to do trail maintenance. We can keep this information in case we have areas that need cleanup and we don't have the means to do it ourselves.

December Meeting: Next Meeting will be Thursday, December 6<sup>th</sup>, 7pm, at a location to be determined. Pat will send out an email to let us know where it will be taking place.
